**Delegation of Powers by the Public Service Commission in terms of

By virtue of the powers vested in terms of paragraph 1 of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, the provisions under No. 17 and 18 of Part I of the Schedule published in the *Gazette Extraordinary* No. 1941/41 dated 20.11.2015 as amended by the *Gazette Extraordinary* No. 2193/30 dated 16.09.2020 by which the Public Service Commission delegated powers are hereby amended with effect from 24.11.2020.
